On March 10, just before COVID-19 curtailed trail work, students from the University of TN at Chattanooga carried lumber and installed a new trail bridge across a gully and small waterfall and stream between Straight Branch and Taylor Valley. Thanks to MRATC life member, Harold Croxton, for his generous donation of funds for the bridge!

The MOUNT ROGERS APPALACHIAN TRAIL CLUB, a member of the Appalachian Trail Conservancy was organized February 29, 1960. The club has maintenance responsibilities for 59.4 miles of the APPALACHIAN TRAIL in the Jefferson National Forest, Mount Rogers National Recreation Area, Grayson Highlands State Park and additional trails in the area.

THE AT AND CORONAVIRUS

In March, the ATC recalled from the Trail the thru-hikers and section hikers who could be reached because of their registration with the ATC, in an effort to stop the coronavirus from spreading among hikers and in trail communities. Trail maintenance clubs suspended work on the trail, since much of this involves working in groups. Trail club members, day hikers and backpackers were urged not to hike on the AT, particularly in groups. Many popular trailhead parking facilities were closed by the Forest Service or other land managing agency.

As of the end of May, many areas are reopening and hikers are getting back out on the Trail, with attention to social distancing, but with a sense of relief in enjoying the outdoors once again. Shelters and privies are still either closed or their use discouraged. AT maintenance clubs are working with their land managing agencies on job hazard analysis and guidance to gradually resume trail work.

MRATC RECREATIONAL ACTIVITIES REPORT

Due to the Coronavirus pandemic, there have been no official club group hikes or potlucks during Spring 2020. Many club members continue to hike, either alone or with a few people and keeping social distancing in mind. Mostly, we have not been hiking on the AT due to ATC recommendations. Especially risky is carpooling to hikes, so mostly, club members have been driving solo or with family\trusted friends only and meeting to hike. So, many of us have explored areas we haven't spent as much time in in the past. Some incredibly beautiful Spring flowers have been seen, and some pictures are in this Blaze. Hopefully, by the time of the fall Blaze, some hiking and group events will resume, but perhaps in a new fashion, with limits on numbers hiking together and carpooling and some social distancing continuing.

TRAILS REPORT

Due to Covid-19 concerns and closures there was no trail work in either April or May but there is hope going forward.

Club representatives joined those from ATC, PATH and the Forest Service in a discussion initiated by MRNRA for the purpose of establishing coronavirus safety guidelines and a new Job Hazard Analysis (JHA) document. Once approved this will allow monitors and maintainers to begin doing some work individually or in very small groups if they are comfortable doing so. We also hope to concurrently roll out a check in/check out procedure for monitors.

More specific information and a copy of the MRNRA JHA and coronavirus safety guidelines will be sent out to club members as plans progress.


NATURAL RESOURCES REPORT

The Natural Resources Committee has nothing much to report, due to all volunteer activities being suspended by the Forest Service and the ATC due to Covid-19. Our activities normally include monitoring rare plants and phenology, controlling invasives, and managing open areas, among others. The good news is that we may be able to resume activities after June 9, and many of our mountain plants are late bloomers. Hopefully, there will be plenty of time for a full season of activities.
